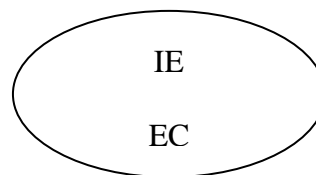

This approval shall cease in the event of the establishment being sold, relocated, ceasing trading or operation or if the owner, being in a partnership that is terminated or being a company is wound up/ceases to be a registered company/goes into liquidation (as appropriate) or being a sole trader dies or is adjudged bankrupt.

Please Note: The following rules apply to the application of the identification number:

Identification Marking (Regulation 853/2004, Annex II, Section I)

The identification mark must be applied before the product leaves the establishment

A new mark need not be applied unless its wrapping/packaging has been removed or it is further process in another establishment.

The mark must be legible and indelible and the characters easily decipherable.

The mark must indicate the name of the country in which the establishment is located, which may be written out in full or as a two-letter code i.e. IE for Ireland.

The establishment may apply the mark to both food that require approval under Regulation 853/2004 and those that do not.

The mark must be oval in shape and bear the letters EC.

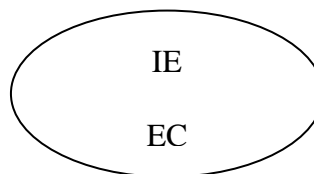
